- 2.0 The grant of the aforesaid revised higher pay scales are subject to the following conditions, namely:-

- (iii) After receipt of the report of the 6th Punjab Pay Commission, no further revision shall be effected in these pay scale/matrix for the newly recruited persons to the aforementioned categories of posts.
- 3.0 It is clarified that these pay matrix shall be applicable to the persons to be recruited in future against the above mentioned posts and shall not be applicable to the existing incumbents in any manner, whatsoever.
- 4.0 This issue is with the advice given by the Department of Finance conveyed vide their UO No. FD-FP-10PYSC/16/2020-1FPI/1094, dated 19.10.2020.
- 5.0 The earlier notification issued vide No. 13/01/2020-5 Edu.7/275, dated 20.10.2020 shall stand withdrawn.
